# 2. Acquisition of Hotel in Japan

Wing Tai Holdings Limited (the "Company") wishes to make the following announcements:

1. Winrise (Japan) TMK, a special purpose *tokutei mokuteki kaisha*, has been incorporated under Japan Law regarding securitization of assets for investment holding purposes.

Winrise (Japan) TMK has an initial issued share capital of 100,000 Japanese Yen, comprising of two specified shares and is currently held by Ippan Shadan Hojin HDG3 (the "ISH")<sup>NOTE</sup>. The establishment of ISH is arranged by Windall Investment Pte. Ltd., a wholly-owned subsidiary of the Company.

2. Winrise (Japan) TMK has entered into a Real Estate Trust Beneficiary Interest Purchase and Sale Agreement (the "PSA") with GK Rio Grande for acquisition of the Red Planet Hotel Asakusa Tokyo (the "Hotel") for a consideration of 4.25 billion Japanese Yen.

The 13-floor Hotel offers 134 rooms as well as a restaurant and commenced operation on 1 August 2015. The Hotel is situated within the Asakusa district and is located close to the Sensoji-Temple (Tokyo's oldest temple) and the nearby Nakamise-dori shopping street. The hotel is also located within walking distance to the Asakusa Train Station on the Tsukuba Express Line and Tawaramachi Station on the Ginza Line.

The acquisition of the Hotel is carried out in the ordinary course of the Wing Tai Group's business.
